#### HOW TO USE

- Please charge the toy fully before first use.
- Hold the button for 2 seconds until the light turns on: the motor enters the work mode.
- Press the button to turn on the work mode, including weak, medium, and strong + 7 vibration edge modes (10 vibration modes).
- 4) Press the button. Any mode can go into the burst function, and the function will be switched off automatically 10 seconds later. You can press the button to switch it off immediately, and go to the previous setting.
- Hold the button for 2 seconds to turn the device off.

#### CHARGING

USB Pin Charging.

- Completely dry the toy before charging.
- When the toy is charging, the light will flash. The light will always be on when the device is fully charged.
- Only use the original charger provided with the toy when charging. DO NOT LEAVE THE CHARGING TOY UNATTENDED!


